Rules & Regulations

1. Application is due on July 16, 2011.
2. The entry fee of \$5/per person is due at check-in on July 30, 2011. ****CASH ONLY**** please
3. If you sign up after the deadline, there will be an additional \$15 flat rate to your entrance fee.
4. Group will contain a MINIMUM of 6 people.
5. Routines will be no longer than 8 minutes.
6. No profane/obscene clothing and/or dance moves. (This is a family event, so please try to keep it as G-rated as possible.)
7. You are responsible for giving the Dance Contest Chairperson your music prior to performance, or when asked for.
8. Make sure your CD/tape is marked with group name and track number for your routine. Philippine Weekend is not responsible for any lost/scratched audios or for returning your audio back to you. (It is also a good idea to have 2 copies, in case there are any technical difficulties.)
9. Philippine Weekend is not responsible for any injuries occurred while performing.
10. Everyone will participate in the preliminary portion of the event, and the top 3 teams will perform for the finals.
11. The 1st place winner is invited back to perform on Sunday, July 31, 2011 at the park.
